**SIGN IN**

Sign in for the Criterium will be located next to 5th Street near the start finish area. Please report to sign in no later than 10 minutes prior to race start.

### **NUMBERS**

Please wear the numbers that you have been given for each of the stages. See display in tech guide for proper placement. Do not wear a single number in the middle of your back! Do not fold, trim or crumple. Hair covering numbers is not allowed. Why all these rules? Altering numbers makes the numbers harder to read for the judges and delays results for everyone. Time penalties may be assessed for not displaying numbers properly.

Stage 1 Time Trial: 1 number, right side

Stage 2 Road Race: 2 numbers, one on each side

Stage 3 Crit: 2 numbers, one on each side

### **MEN 15-18 Race Duration**

To clarify a discrepancy between the technical guide and the race flyer, the Men 15-18 will race for 35 minutes. No change to the scheduled start time.

### **PROTESTS**

Remember – protest rules are different for stage racing. Results protests should be directed to Chief Judge Lynn Taylor. All other protests are directed to Chief Referee Michael Christopher. Protests shall be filed before the start of the next stage or within 15 minutes after the corresponding category's criterium results posting.
